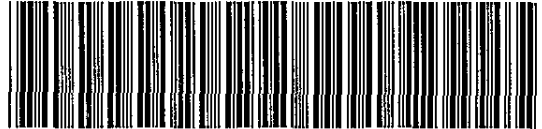

ARTICLES OF INCORPORATION
OF
C D QUALITY SERVICE CORPORATION

ARTICLE I - NAME

The name of this Corporation is C D QUALITY SERVICE CORPORATION






