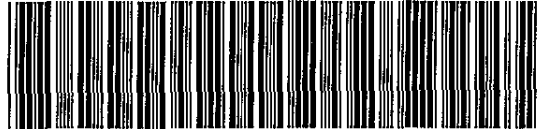

**ARTICLES OF INCORPORATION**

**of**

**CAMS AIRCRAFT INTERIORS, INC.**

I, MATTHEW H. MALOUF, the undersigned, do hereby associate myself for the purpose of forming and becoming a corporation for profit, under the laws of the State of Florida, and do hereby certify that they have become such corporation under and pursuant to the following Articles of Incorporation.

**ARTICLE I - NAME**

The name of this corporation is: **CAMS AIRCRAFT INTERIORS, INC.**  
located at  
328 Disston Avenue North, Tarpon Springs, FL 34689

**ARTICLE II - NATURE OF BUSINESS**

The general nature of the business to be transacted by this corporation is as follows:

1. To engage in the business to renovate, refurbish, design and restore aircraft and aircraft interiors including upholstery, paneling, carpeting, instrument panels and develop design technology and do all things cosmetic as well as airworthy, in accordance with FAA Regulations. To develop methods, processes and inventions related to aircraft improvements, and to buy, sell, rent and lease aircraft.

2. To conduct business in, have one or more offices in, and buy, hold, mortgage, sell, convey, lease, rent or otherwise dispose of real and personal property, including franchises, patents, copyrights, trademarks, and licenses in the State of Florida and in all other states and countries.

3. To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness and execute such mortgages, transfers of corporate property, or other instruments to secure the payment of corporate indebtedness as required.

4. To purchase the corporate assets of any other corporation and engage in the same or other character of business.

5. To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the shares of the capital stock of, or any bonds, securities, or other evidences of indebtedness created by any other corporation of the State of Florida or any other state or government, and while owner of such stock to exercise all the rights, powers and privileges of ownership, including the right to vote such stock.

6. To acquire, by purchase, lease, manufacture or otherwise, any personal property deemed necessary or useful in the equipment, furnishings, improvement, development or management of any property, real or personal, at any time owned, held, or occupied by the corporation, and to invest, trade, and deal in any personal property deemed beneficial to the corporation, and to lease, rent, encumber or dispose of any personal property at any time owned or held by this corporation.

7. To buy and sell all kinds of property, both real and personal, to borrow money, issue promissory notes and other evidence of indebtedness.
