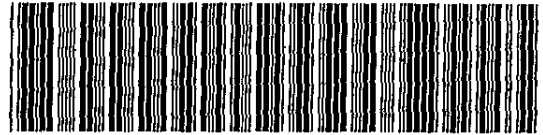

- FIRST: The name of the corporation is JOHN LAROCQUE PAINTING, INC.
- SECOND: The period of its duration is Perpetual
- THIRD: The purpose(s) for which the corporation is organized are "To operate a painting company and any other lawful business for which corporations may be incorporated under Chapter 607 of the Florida Statutes.
