ARTICLES OF INCORPORATION OF WILLIAM BEAMON FRAMING SUBCONTRACTOR, INC.

The undersigned, acting as Incorporator of a Corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such Corporation:
