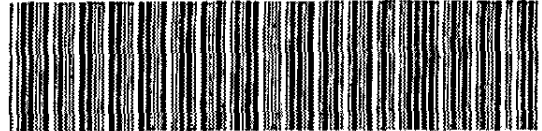

The name of this corporation is: **Quality Construction by Wolfe, Inc.,**

ARTICLE II

The term of existence of the corporation is perpetual.

ARTICLE III

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of \$1.00 par value common stock.
