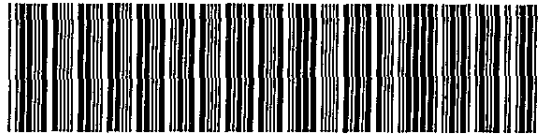

**ARTICLES OF INCORPORATION  
OF

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of corporation.

**ARTICLE I- NAME AND ADDRESS**

**ARTICLE II- DURATION**

The duration of the Corporation is perpetual

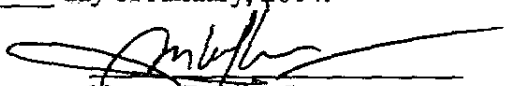
