ARTICLES OF INCORPORATION

OF

OAK PLACE AUTO BODY SHOP, INC.

The undersigned subscribers, each a natural person competent to contract, hereby form a corporation under the laws of the State of Florida, and adopt the following Articles of Incorporation:

#### ARTICLE I - NAME

The name of the corporation shall be OAK PLACE AUTO BODY SHOP, INC.

#### ARTICLE II - PRINCIPAL PLACE OF BUSINESS

The initial principal place of business of this corporation in the State of Florida shall be 630 Oak Place, P, Port Orange, FL 32127. The Board of Directors from time to time may move the principal office to any other address in Florida.

# ARTICLE III - NATURE OF BUSINESS

The general purposes for which the corporation is organized are:

- 1. To transact any lawful business for which corporations may be incorporated under the laws of Florida;
