

Articles of Incorporation
Of
Austin Finishing Inc.

The undersigned subscribes to these Articles of Incorporation, natural persons competent to contract, form this corporation under the Laws of the State of Florida.

ARTICLE 1

Name

The name of this corporation is Austin Finishing Inc.

ARTICLE 2

Nature of Business

The general nature of business to be transacted by this corporation is that this corporation may engage in any activity or business permitted under the Laws of the United States and of the State of Florida, except that this corporation shall not conduct a banking, safe deposit, trust, insurance, surety, express, railroad, canal, telephone, cemetery company, fraternal benefit society, state fair, exposition company, or engineering company.

ARTICLE 3

Shares of stock

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is ONE HUNDRED (100) shares of common stock of the par value of ONE DOLLAR and no/100 Dollars (\$1.00) per share only, making the total authorized capital stock of this corporation ONE HUNDRED DOLLARS and no/100 Dollars (\$100.00).
