### ARTICLES OF INCORPORATION

OF

### D'ALESSANDRO, INC., A NEW FLORIDA CORPORATION

The undersigned subscribers to these Articles of Incorporation hereby forms a corporation under the laws of the State of Florida.

### **ARTICLE I**
