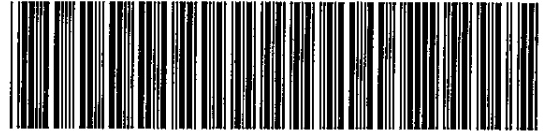



Of


