CERTIFICATE OF INCORPORATION OF

BARRINGTON IRVING REALTY, INC.

For the purpose of forming a corporation for profit under the general incorporation laws of the State of Florida, it is respectfully requested of the Secretary of State the approval of such incorporation under the following articles.

ARTICLE 1

The name of this corporation shall BARRINGTON IRVING REALTY, INC. and its principal place of business shall be in South Florida with the right to change and move said principal place of business and establish such other offices and places of business within or without the State of Florida as the Board of Directors may from time to time deem proper.

The amount of capital with which this corporation shall begin shall be not less than one thousand dollars (\$1000.00).


ARTICLE V
