

**ARTICLES OF INCORPORATION
OF

Under Chapter 607 Florida Statutes

IT IS HEREBY CERTIFIED THAT:

- (1) The name of the proposed corporation is Adam Turco, Inc.
- (2) The purpose for which this corporation is formed is the transaction of any or all lawful business for which corporations may be incorporated under this chapter.
- (3) The office of the corporation is to be located in the city of Palm Bay, County of Brevard, State of Florida.
- (4) The aggregate number of shares, which the corporation shall have the authority to issue, is One Hundred (100), one class only, no par value.
