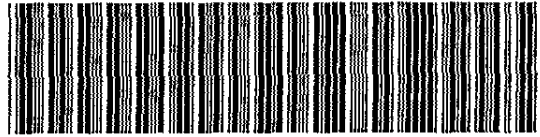



**ARTICLES OF INCORPORATION
OF**

ARTICLE I - NAME

The name of this Corporation shall be:
Paul Carlisle Plumbing, Inc.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing
on 01/05/04.

ARTICLE III - PURPOSE
