ARTICLES OF INCORPORATION OF C&C Properties of South Florida, Inc.

ARTICLE I - NAME AND BUSINESS ADDRESS

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

ARTICLE IV - CAPITAL STOCK
