The undersigned hereby forms a corporation for profit under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be General Beverage, Inc. The Board of Directors may from time to time move the Principle Office to any other address in the State of Florida.
