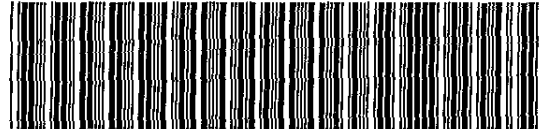

**ARTICLES OF CORPORATION**

**ARTICLE I - NAME**

The name of this corporation is:
