ARTICLES OF INCORPORATION

The undersigned incorporators hereby executes and acknowledges these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I

Name

The name of this corporation shall be:

ARTICLE II

Business and Purposes

The general nature of the business to be transacted by this corporation, or the objects or purposes of this corporation, shall be to conduct any business operation legal under the laws of the state of Florida.

ARTICLE III

Capital Stock

- !. The aggregate number of shares of capital stock authorized to be issued by this corporation shall be 100 shares of common stock with no par value. Each share of said stock shall entitle the holder thereof to one vote at every annual or special meeting of the stockholders of this corporation. If filed after such five (5) days, the existence of this corporation shall commence upon the filing of these Articles with the Department of State. In either event, the existence of this corporation thereafter shall be perpetual.

ARTICLE V

Corporation's Principal Office

The corporation's principal office shall be located at 1074 Bannerman Road, Tallahassee, Florida 32312.

ARTICLE VI

Registered Office and Registered Agent

The initial registered office of this corporation shall be located in 1074 Bannerman Road, Tallahassee, Florida 32312, and the initial registered agent of this corporation at such office shall be Michael Blount. This corporation shall have the right to change such registered office and such registered agent from time to time, as provided by law.

ARTICLE VII

Board of Directors

The Board of Directors of this corporation shall consist of not less than one (1) nor more than five (5) members, the exact number of directors to be fixed from time to time by the stockholders, or by-laws.
