

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF GREEN DEVCO II, INC.



Pursuant to the provisions of Florida law, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the Corporation is GREEN DEVCO II, INC.
- 2. The Corporation has not yet issued shares, therefore, pursuant to Florida Statute Section 607.1005, shareholder action is not required.
- 3. The following Amendment of the Articles of Incorporation was adopted by the sole incorporator of the Corporation on the 1st day of May, 2004, in the manner prescribed by Florida law.

Article V of the corporate charter filed on January 20, 2004, is amended as follows:

"ARTICLE V Capital Stock

The Corporation is authorized to issue one hundred (100) shares of One Dollar (\$1.00) par value common stock which shall be designated "Class A Voting Common Shares"; and one hundred (100) shares of One Dollar (\$1.00) par value common stock which shall be designated "Class B Nonvoting Common Shares". The Class A and Class B shares shall be entitled in all respects to equal rights and privileges except that each share of Class A shall be entitled to one (1) vote and each share of Class B shall be nonvoting stock."

4. This Amendment shall become effective immediately upon filing with the Department of State of Florida.
