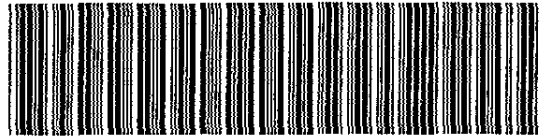

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I
NAME

The name of the corporation shall be North Central Florida Residential & Commercial Construction Co.

ARTICLE II
Principal place of business and mailing address

The principal place of business of this corporation shall be 505 Lafayette Avenue, Live Oak, FL 32064 and mailing address shall be P.O. Box 6141, Live Oak, FL 32064. The Board of Directors may from time to time move the Principal Office to any other address in Florida.

This corporation is to exist perpetually, unless sooner dissolved according to Law.


ARTICLE IX
