

ARTICLES OF INCORPORATION OF SCHIPPER CONSTRUCTION, INC., a Florida corporation

The undersigned, acting as incorporator of a corporation pursuant to Chapter (\$37) of the Florida Statutes, adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of this corporation is SCHIPPER CONSTRUCTION, INC.

ARTICLE II - PURPOSE

This corporation is organized for the purpose of transacting any or all Lawful business.

ARTICLE III - TERM OF EXISTENCE

This corporation shall begin its existence on January 12, 2004, and shall exist thereafter perpetually.
