SECRETARY OF STATE ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS AHASSEE FLORIDA

The name of this corporation is AMARK TRENDS, INC. and its principal place of business shall be located at 753 Lake Drive, Melbourne, FL 32940.
