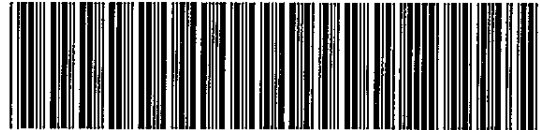

The undersigned, each a natural person, competent to contract, hereby subscribes to these Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

ARTICLE I

NAME. The name of the corporation is:

DAVID SCHADLE CONSTRUCTION, INC.

ARTICLE II

ARTICLE III

PURPOSE OF BUSINESS. This corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV

CAPITAL STOCK. The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 500 shares of common stock having a nominal or par value of \$1.00 per share.

ARTICLE V

PREEMPTIVE RIGHTS. Each shareholder of the corporation shall be entitled to full preemptive rights to acquire his proportional part of any unissued or treasury shares of the corporation, or securities of the corporation convertible into or carrying a right

to subscribe to or acquire such shares, which may be issued at any time by the corporation.

ARTICLE VI

INITIAL CAPITAL. The amount of capital with which the corporation will begin business is \$500.00

ARTICLE VII

TERM OF EXISTENCE. This corporation shall begin its corporate existence on the date of the filing of these Articles of Incorporation and shall exist perpetually thereafter.

ARTICLE VIII

REGISTERED OFFICE AND AGENT. The street address of the initial registered office of this corporation is 10536 Bay Hills Circle, Thonotosassa, FL 33592, and the name of the corporation's initial registered agent at such address is **DAVID F. SCHADLE**.

ARTICLE IX

DIRECTORS. This corporation shall have one (1) Director(s) initially. The number of Director(s) may be increased or diminished from time to time by the By-Laws adopted by the stockholders, but the number of Directors shall not be less than one (1).


