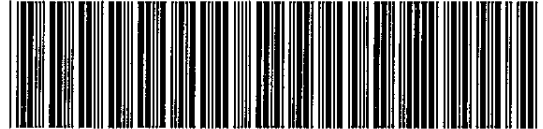



Article XIII – Amendment



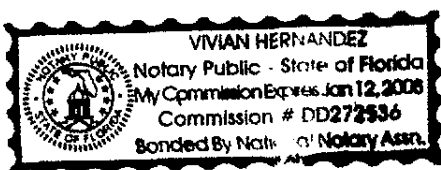
