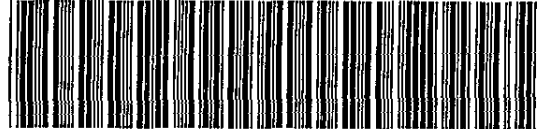



The adoption date of these Articles of Amendment shall be January 8, 2004.


