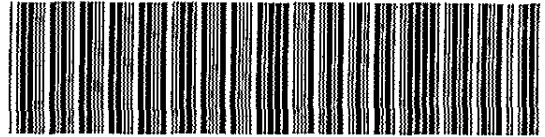

**ARTICLES OF INCORPORATION OF
SALON SUGAR, INC**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation shall be: SALON SUGAR, INC.

ARTICLE II – PRINCIPAL OFFICE

The principal place of business / mailing address is:

ARTICLE III – PURPOSE

The purpose for which the corporation is organized is: for any legal business purposes as allowed by Florida law under the Florida Business Corporation Act.

ARTICLE IV – SHARES

The number of shares of stock is: Twenty thousand (20,000) shares of Common Stock.
Par value one dollar (\$1.00) per share.

ARTICLE V – SALE OF SHARES BY SHAREHOLDERS

If any shareholder of Salon Sugar, Inc. wishes to sell their shares of stock, the first offer to sell must be made to the Corporation by certified mail. If rejected by the Corporation, then next offer shall be to the remaining shareholders of the Corporation. The rights of refusal by the Corporation shall be 60 days from the date of notice by the seller. If rejected by the Corporation by certified mail to the seller, the remaining shareholders shall have 30 days from the Corporation refusal date. The repurchase price shall not exceed the fair market value of the stock.

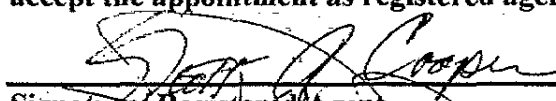
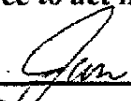
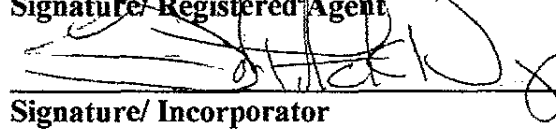
