ARTICLES OF INCORPORATION

OF

ISLAND MEAT & FISH SUPERMARKET INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the Corporation is:

ISLAND MEAT & FISH SUPERMARKET INC.




