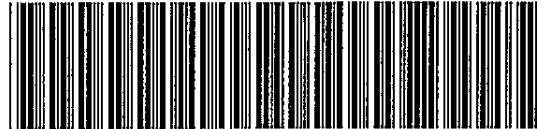

The undersigned for the purposes of forming a corporation under the Florida General Corporation Act hereby adopts the following Articles of Incorporation:

Article I. Name


