ARTICLES OF INCORPORATION
OF

ARTICLE I
NAME



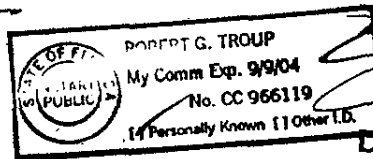

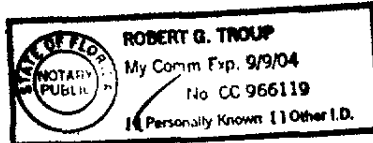
