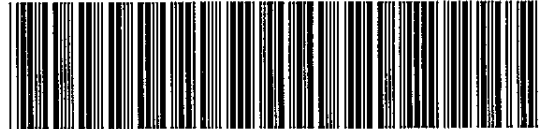

**ARTICLE I - CORPORATE NAME**

The name of this corporation is GARY TROMBLEY'S FLOORING, INC., whose principal office and mailing address is 1100 Sanchez Street SE, Palm Bay, Florida 32909.

**ARTICLE II - NATURE OF BUSINESS AND POWERS**

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

#### **ARTICLE X - AMENDMENT**

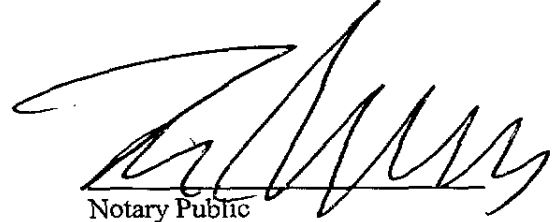

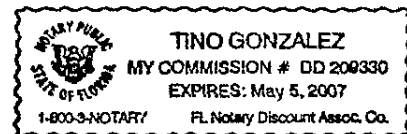
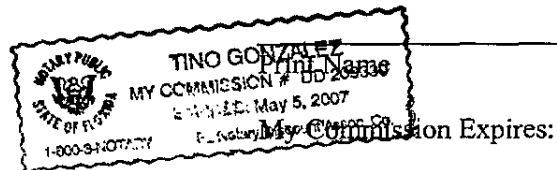
