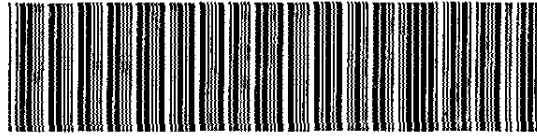

We the undersigned, all of whom are of legal age, do hereby associate ourselves for the purpose of becoming a corporation under the law of the State of Florida, authorizing the formation of corporation.

Article I

The name of this corporation shall be: Brunel Painting Inc.

Article II

The principal place of business of said corporation shall be at: 15050 SW 89 Ct., Miami, FL 33176.

Article III

The general nature of the business and the objects and purposes proposed to be transacted and carried on are to do any and all of the things herein mentioned as fully and to the same extent as natural might or could do and, in addition thereto, engage in any activity or business permitted under the law of the State of Florida, for example:

- Provide general painting, faux finish, wall texturing, wallpapering and waterproofing.
- Home decorators from property renovations, commercial offices, and residential with a high quality interior or exterior painting.

Article IV

Capital Stock

The capital stock of this corporation shall be three hundred (300) shares, \$1.00 par value common stock. This stock shall to dividends, and shall be issued fully paid and non-assessable. The stock shall be restricted as to transfer as to follows: These stocks may not be transferred on the books of the corporation without first giving the right of purchase for ten days (10) and thereafter to the corporation at the book value of the stock, and thereafter for five (5) days to any stockholders of record at the same price and terms of any bona fide offer which the holder may desire to accept.

The amount of capital with which this corporation shall commence business shall not be less than Five Hundred (\$500.00)

Article V

Board Directors

The number of Directors may be altered from time to time by the By-Laws adopted by the Stockholders, however, this corporation shall have no less than one (1) Director at any time.

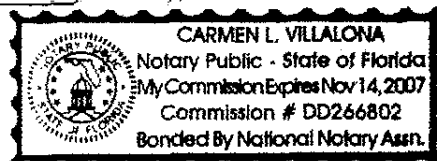

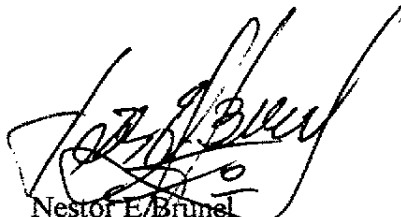
