The undersigned, for the purpose of forming a corporation under the Floridal AHASSEE FLORIDA General Corporation Act, hereby adopts the following Articles of Incorporation.

# ARTICLE I

The name of the corporation shall be Estuarine, Coastal, and Ocean Science, Inc., hereinafter referred to as the "corporation".

This corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.
