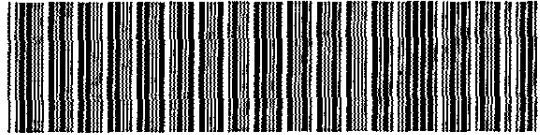

KNOW ALL MEN BY THESE PRESENTS: that the undersigned, acting as incorporators of a Corporation under Chapter 607 of the Florida Statutes, do hereby adopt the following Articles of Incorporation:

ARTICLE I. NAME

The name of this Corporation is: KWWD, INC., whose address is: 1108 H.L. Smith Road, Haines City, Polk County, Florida 33844.

ARTICLE II. NATURE OF BUSINESS

The Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III. CAPITAL STOCK

The total authorized capital stock of this Corporation shall be one hundred (100) shares of common stock at one dollar (\$1.00) par value, all of said common stock being fully paid and non-assessable.

ARTICLE IV. PREEMPTIVE RIGHTS

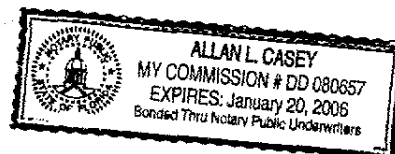
