#### ARTICLES OF INCORPORATION

#### ARTICLE I - NAME

The name of this Corporation is K & T TRADING CORPORATION.

#### ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing upon filing of these Articles.

#### ARTICLE III - PURPOSE

This Corporation is organized for the following purposes:

- A. To engage in the business of importing and exporting goods of every kind, type and description; to purchase and sell such goods as a wholesaler, distributer, or otherwise, and to act as an agent or broker in the sale of goods of every kind, type, and description; and to do all things as are necessary to the accomplishment of the purposes set forth herein.
