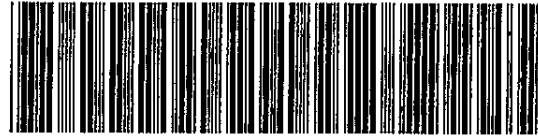

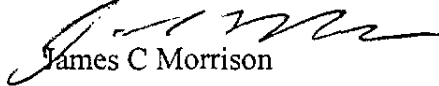

ARTICLE I

NAME

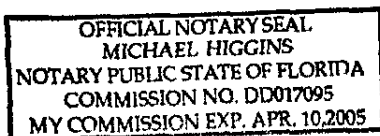

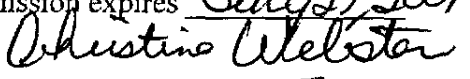
