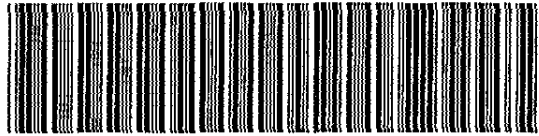

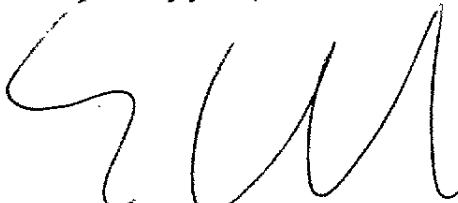

ARTICLE I — NAME

The name of this corporation is **ENGINEERING FIRST CLASS, INC.**

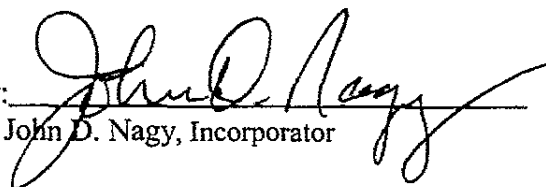

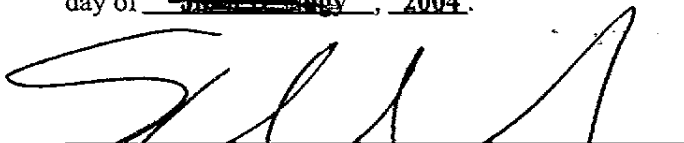

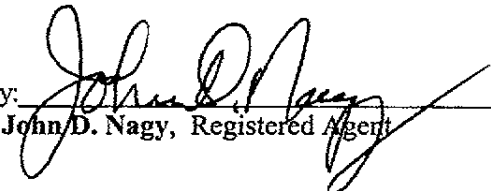
