Articles of Incorporation Of RIMES AND SON AGRICULTURAL SERVICE, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person component contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation is RIMES AND SON AGRICULTURAL SERVICE, INC.

ARTICLE II - NATURE OF BUSINESS

The general character, purpose, and nature of business to be transacted by this corporation is to provide citrus tree removal and land clearing, as well as any other activity or business legally permissible under the applicable laws of the State of Florida or the United States of America.
