

OF

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation is Boo's Construction Services, Inc.

ARTICLE II: PRINCIPAL OFFICE

ARTICLE III: DURATION

The duration of the corporation is perpetual.

ARTICLE IV: PURPOSE

The name and address of the incorporator of these Articles of Incorporation is Christina Crivello, 3422 Austin St., Sebring, Florida 33872.


