

We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the formulation, liability, rights and privileges and immunities of a corporation for profit.

#### ARTICLE I- NAME

The name of the corporation shall be \_\_NEIL'S WOOD WORKING, INC.

#### ARTICLE II- OFFICE

The principal office of this corporation shall be situated at 1856 MACKENZIE COURT NORTH MIDDLEBURG, FLORIDA 32068 and said corporation shall have the rights and privileges of business in such states of the United States and foreign countries whenever the Board of Directors may from time to time order and establish.
