# ARTICLES OF INCORPORATION OF DEVORE EXTERIOR DESIGNS, INC.

The undersigned, being of legal age and competent to contract for the purpose of organizing a business corporation pursuant to the laws of the State of Florida, does hereby adopt the following Articles of Incorporation under Florida Statutes, Chapter 607, and other laws of the state of Florida, and does hereby agree and certify as follows:

## ARTICLE I

The name of this Corporation shall be DEVORE EXTERIOR DESIGNS, Inc. (herein "Corporation").

### ARTICLE II COMMENCEMENT OF CORPORATE EXISTENCE

This corporation shall commence corporate existence immediately upon filing with the Florida Department of State, and shall have perpetual existence unless sooner dissolved according to law.

### ARTICLE III PURPOSES AND GENERAL POWERS

The Corporation is formed to engage in every phase and aspect of lathe work on commercial and residential jobsites throughout the United States that is deemed viable and profitable. This Corporation shall have all of the powers enumerated in the Florida Business Corporation Act, as the same now exists and as hereafter amended, and all such other powers as are permitted by applicable law, including, without limitation and only by illustration, the following:

- (a) To have a corporate seal, which may be altered at pleasure, and to use the same by causing it, or a facsimile thereof, to be impressed, affixed, or in any other manner reproduced.
- (b) To purchase, take, receive, lease, or otherwise acquire, own, hold, improve, use, and otherwise deal in and with real personal property or any interest therein, wherever situated.
- (c) To sell, convey, mortgage, pledge, create a security interest in, lease, exchange, transfer, and otherwise dispose of all or any part of its property and assets.
- (d) To lend money to, and use its credit to assist, its officers and employees.
- (e) To make contacts and guarantees and incur liabilities, borrow money at such rates of interest as the Corporation may determine, issue its notes, bonds, and other obligations, and secure any of its obligations by mortgage or pledge of all or any of its property, franchises, and income.
- (f) To enter into, make, receive assignments of, grant assignments of, and perform contracts of every nature and kind for any lawful purpose. To enter into, make, receive assignments of, grant assignments of, and perform contracts of every nature and kind for any lawful purpose.
- (g) To lend money for its corporate purposes, invest and reinvest its funds, and take and hold real and personal property as security for the payment of funds so loaned or invested.

- To conduct its business, earry on its operations, and have offices and exercise the powers granted (h) by the Florida Business Corporation Act or by other applicable law within or without the State of Florida.
- To eject or appoint officers and agents and define their duties and fix their compensation. (i)
- To make and after bylaws, not inconsistent with its Articles of Incorporation or with the laws of **(i)** the State of Florida, for the administration and regulation of its affairs.
- To promote, by all proper and legitimate agencies and means, education and educational (k) institutions generally, and any and all charitable, religious, scientific and educational movements, purposes or causes, to make gifts and donations for the public welfare or for charitable, religious, scientific or educational purposes.
- To transact any lawful business, which its Board of Directors shall find, will be in aid of (1) governmental policy.
- To pay pensions and establish and carry out pension plans, profit sharing plans, stock bonus (m) plans, retirement plans, benefit plans, stock option plans, and other incentive and compensation plans for may or all of its directors, officers, and employees and for any or all of the directors, officers, and employees of its subsidiaries.
- (n) To provide insurance for its benefit on the life of any of its directors, officers, or employees, or on the life of any shareholder for the purpose of acquiring at his or her death shares of its stock owned by the shareholder or by the spouse or children of the shareholder.
- (o) To be a promoter, incorporator, general parmer, limited partner, member, associate, or manager of any corporation, partnership, limited partnership, joint venture, trust, or other enterprise.
- To have and exercise all powers necessary or convenient to affect its general purpose. (p)

# ARTICLE IV CAPITAL STOCK

I. Number and Class of Shares Authorized Par Value.

The capital stock authorized, the par value thereof, and the class of such stock shall be as follows:

The consideration for all of the above stock shall be payable in cash, property (tangible and intangible), labor or services in lieu of cash; at a just valuation to be fixed by the Board of Directors of the Corporation.

2. Voting Rights.

> Shareholders shall possess and exercise exclusive voting rights and at all meetings of the shareholders, each record holder of such stock shall be entitled to one vote for each share held.

3. Restraint On Alienation Of Shares.

The shareholders of the Corporation shall have the power to include in the Bylaws, or by separate agreement adopted by a majority of the shareholders of the Corporation, any regulatory or restrictive

provisions regarding the proposed sale, transfer, or other disposition of any of the outstanding stock of the Corporation by any of its shareholders. The manner and form, as well as the relevant terms, conditions, and details, of the disposition shall be determined by the shareholders of the Corporation; provided, however, that such regulatory or restrictive provisions shall not affect the rights of third parties without actual notice of the provisions unless the existence of the provisions is plainly noted on the certificate evidencing the ownership of such stock.

### ARTICLE Y INITIAL REGISTERED AND PRINCIPAL OFFICE AND AGENT

The initial registered and principal office of this Corporation shall be located at 1260 Blackfoot Avenue, Orlando, Florida 32826, and the initial registered agent of the Corporation at that address shall be RUEL B. DEVORE. The Corporation may change its registered agent or the location of its registered office, or both, from time to time without amendment of these Articles of Incorporation.

#### ARTICLE VI INITIAL BOARD OF DIRECTORS

This Corporation shall have one director initially. The number of directors may be either increased or diminished from time to time as provided in the Bylaws. The name and street address of the initial director of this Corporation is:

### ARTICLE VIII BYLAWS

Except as otherwise provided by law, the power to adopt, after, amend or repeal the Bylaws shall be vested in the Board of Directors.

## ARTICLE IX INDEMNIFICATION

In addition to any rights and duties under applicable law, the Corporation shall indemnify and hold harmless all of its directors, officers, employees and agents, and former directors, officers, employees and agents from and against all liabilities and obligations, including attorncy's fees, incurred in connection with any actions taken or failed to be taken by said directors, officers, employees and agents in their capacity as such except for willful misconduct or gross negligence.

No contract or other transaction between this Corporation and any other corporation, and no act of this Corporation, shall in any way be affected or invalidated by the fact that any of the Directors of this Corporation are pecuniarily or otherwise interested in, or are the directors or officers of, such other corporation. Any Director individually, or any firm of which any Director may be a member, may be party to, or may be pecuniarily or otherwise interested in any contract or transaction of this Corporation, provided that the fact that he or she or such firm is so interested shall be disclosed or shall have known to the Board of Directors or a majority thereof, and any Director of this Corporation who is also a director or an officer of such other Corporation or who is so interested may be counted in determining the existence of a quorum at any meeting of the Board of Directors of this Corporation which shall authorize any such contract or transaction with like force and effect as if he or she were not such a director or officer of such other corporation, or not so interpreted.

### ARTICLE XI LIMITED LIABILITY OF SHAREHOLDERS

The private property of the shareholders shall not be subject to payment of the Corporation's debts to any extent.

### ARTICLE XII AMENDMENT

This Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.

### ARTICLE XIII HEADING AND CAPTIONS

The headings or captions of these various Articles are inserted for convenience hereinbefore named, for the purpose of forming a corporation under Florida Statutes, Chapter 607, and other laws of the state of Florida, to do business both within and out of the State of Florida, does hereby make and file these Articles of Incorporation declaring and certifying that the facts stated herein are true, and hereby subscribe thereto and hereunto set his hand and seal this 2/ day of January, 2004.
