ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is Bench Ads Management Of South Florida, Inc. Its principal office address and business mailing address is 19589 NE 10 Avenue, North Miami, Florida 33179.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE


