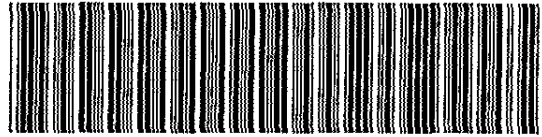

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I
NAME

The name of the corporation shall be Affordable Tractor Sales & Services, Inc.

ARTICLE II
Principal place of business and mailing address

The principal place of business of this corporation shall be 24458 49th Road, O'Brien, FL, 32071 and mailing address shall be 24458 49th Road, O'Brien, FL 32071. The Board of Directors may from time to time move the Principal Office to any other address in Florida.

This corporation is to exist perpetually, unless sooner dissolved according to Law.


ARTICLE IX


