ARTICLES OF INCORPORATION For John Collins, P.A.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the Corporation is John Collins, P.A. Principal place of business is I Fawlkland Circle, Boyton Beach, FL 33426.
