

ARTICLE I CORPORATE NAME

The name of the corporation shall be ISAACS WILLIAMS & ASSOCIATES, P.A.

ARTICLE II COMMENCEMENT OF THE CORPORATE EXISTENCE

The corporate existence commences on the 15th day of January, 2004.

ARTICLE III PRINCIPAL OFFICE

The mailing address of this corporation, ISAACS WILLIAMS & ASSOCIATES, P.A., is 846 Sanctuary Cove Drive, North Palm Beach, FL 33410.

ARTICLE IV CAPITAL STOCK

The number of shares of stock that this corporation is authorized to have outstanding at any one time is one thousand (1,000) at \$1.00 par value.

A) Board of Directors.
