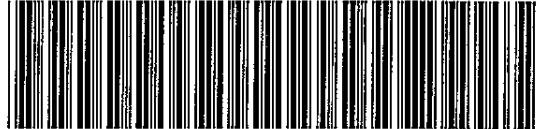

Article I- Name

The name of this corporation is SNYDER PROPERTIES COOLIDGE, INC.

Article II- Principle Office

The mailing address and principle office of the corporation is: 840 Samms Avenue, Port Orange, Florida 32129

Article III- Duration

This corporation shall have perpetual existence.

Article IV- Purposes

The general purposes for which this corporation is initially organized is as follows: To engage in all aspects of the purchase and management of real properties, to design, manufacture, assemble, sell, install, distribute or otherwise deal in all types of equipment, appliances, products, and devices; to own personal property; to own, hold, lease, improve, and develop real estate; engage in any type of lawful business; lend or borrow money, and to draw, make, accept, discount, and issue promissory notes, bills of exchange and other negotiable instruments, and to secure the same of mortgage or otherwise; to have offices and officers, agents and agencies in the State of Florida or in any other of the states of the United States, or any dependencies of the United States, or in foreign countries; and to exercise generally such powers as may be incident to or convenient for the purposes and businesses of the corporation and to engage in any activity or business as permitted under the laws of the United States and the State of Florida, it being expressly provided that the foregoing enumeration of specific powers shall not be held to limit or restrict the general powers of the corporation.

Article V- Capital Stock

The maximum number of shares of stock which this corporation is authorized to have outstanding at any time shall be one hundred thousand (100,0000) shares of common voting stock with a par value of ten cents (\$.10) per share. All stock issue shall be fully paid

Article VI- Preemptive Rights

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class, or series as that which he already holds, shall have the right to purchase his *prorata share thereof* (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

Article VII- Initial Board of Directors

This corporation shall have one director initially. The number of directors may be either increased or diminished from time to time by the bylaws, but shall never be less than one. The name and address of the initial director of this corporation is:

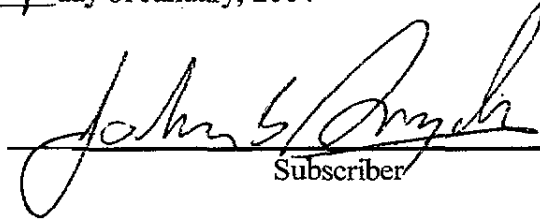
Article X- Indemnification

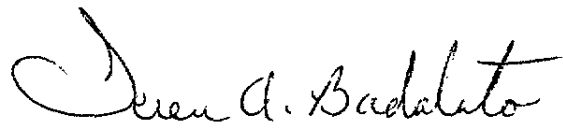

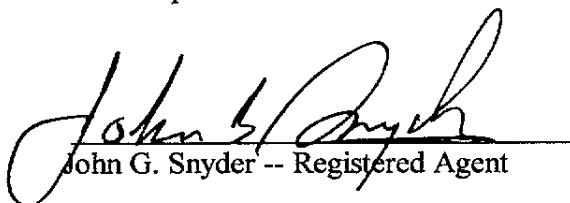

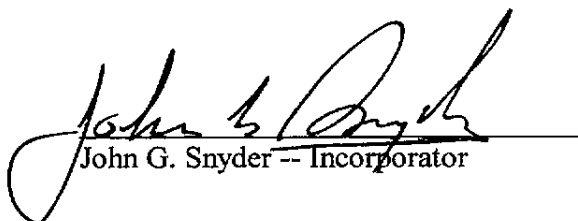
