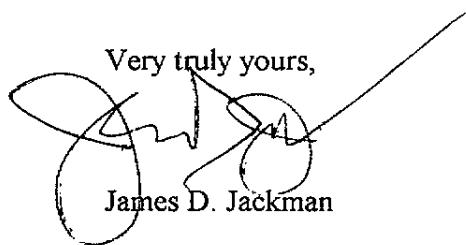

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation is Radiant Resurfacing, Inc.

ARTICLE II

The effective date of the Corporation shall begin upon the filing of the articles of incorporation.

ARTICLE III

The street address of the principal office of the Corporation is 4427 56<sup>th</sup> St. W., Bradenton, FL 34210.

ARTICLE IV

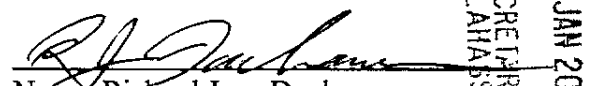
