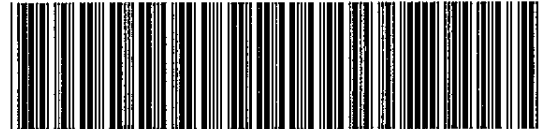

ARTICLE I - NAME

The name of this Corporation is UNIVERSAL WHOLESALE & MEDICAL  
EQUIPMENT COMPANY

ARTICLE II - DURATION

The Corporation shall have perpetual existence commencing on the dates these Articles  
of Incorporation are filed with the Florida Secretary of State's Office.

ARTICLE III - PURPOSE

The Corporation may engage in any activity or business permitted under the laws of the  
United States and the State of Florida.

ARTICLE IV - CAPITAL STOCK

The Corporation is authorized to issue One Hundred (100) shares of One Dollar (\$1.00)  
par value common stock, which shall be designated as "Common Shares".




