

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

Article I Name

The name of the corporation shall be Tamski Racing, Inc.

Article II Principle Office

Article III Shares

The number of shares of stock this corporation is authorized to have outstanding at any one time is 100,000 shares of common stock.

The par value of each share of common stock of this corporation shall be \$1.00.

The initial and sole director of this corporation shall be Sue A. Tamski. She may resign at any time, but only after qualifying and admitting her replacement as director of this corporation.
