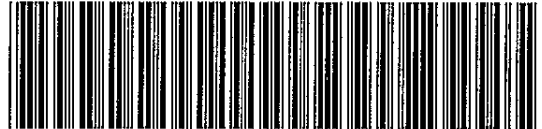

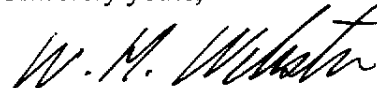

The undersigned incorporators, for the purpose of forming a Florida for profit corporation, do hereby adopt the following Articles Of Incorporation for JOSE HERNANDEZ MASONRY, INC., a Florida for-profit corporation, pursuant to the Florida General Corporation Act:

1. NAME: The name of the corporation shall be JOSE HERNANDEZ MASONRY, INC..
2. PRINCIPAL PLACE OF BUSINESS: The principal place of business is 6310 Second Street, Key West, FL 33040 and the mailing address of the corporation is 13 Allamanda Terrace, Key West, FL 33040.
3. PURPOSE: The purpose of the corporation shall be to perform any act which is lawful under the laws of the State of Florida and the laws of the United States of America.
4. DURATION: The duration of the corporation shall be perpetual.

8. AMENDMENT: These Articles of Incorporation and the Bylaws of the Corporation may be amended upon regular or special meeting of the stockholders and by majority vote.

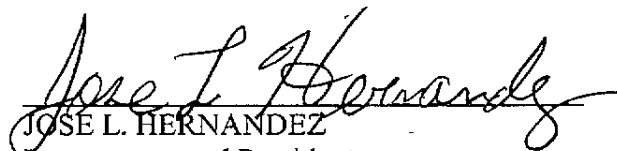

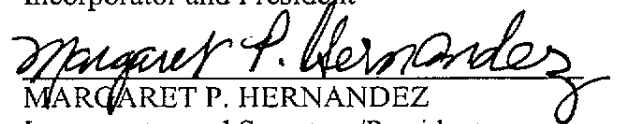

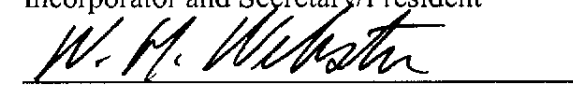
