#### ARTICLE VI


The initial registered agent of this corporation shall be Neftal Nazario, 2540 Groveland Avenue, Deltona, Florida 32725.

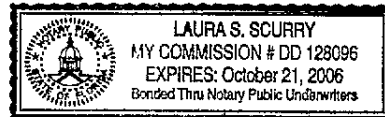
