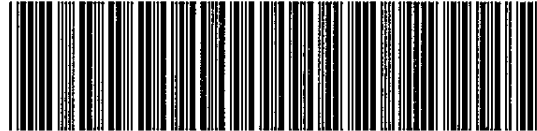

I


## XIII


